Courtroom testimony report

LeSabre sedan, bro	own in color, bearing Wisconsin Registration
plate #ARG1538 tra	avelling north on main street passing first
avenue.	

I ran the license plate of the car and the registered owner, FRANK/F/REYNOLDS Male/white with a date of birth of 7/18/1969, had a suspended driver license.

I pulled behind the vehicle and activated my squad car's emergency lights and sirens. It came to a stop in the 600 block of Main street.

Upon contact, I identified the driver of the vehicle to be DEANDRA/D/REYNOLDS Female/white with a date of birth of 5/22/1990. I advised her the reason of the stop and she stated Frank was her father and sold her the car.

During my contact with the driver, I smelled an odor of marijuana emanating from the vehicle. I asked Deandra when the last time someone had smoked marijuana in the vehicle was, and she said yesterday when she drove her brother to pick up some tools.

I called for a backup officer and ordered Deandra out of the vehicle. Shortly thereafter, Officer Bauer arrived on scene and stood by with Deandra.

I performed a search of the vehicle and located the following items of evidence:

- A sunglasses case containing a burnt glass pipe with burnt copper mesh wiring, located in the center console, which later field tested positive for crack/cocaine base
- A small ziplock bag containing a small amount of unknown white powder, located in Deandra's center bill fold of her purse, which later field tested positive for cocaine. The powder itself weighed. 0.04 grams
- A Taurus G2C 9mm handgun bearing serial number 29D68247, located under the front driver's seat. This was loaded with 10 rounds of ammunition with 1 of those rounds being in the chamber

I ran the serial number of the firearm, and it came back as stolen through the Hartford Police Department. I received a hit confirmation, via dispatch, that the firearm was confirmed as stolen. While awaiting that response, I asked dispatch to advise of any criminal history with Deandra. They advised Deandra had prior felony convictions for Fraud.

I placed Deandra under arrest for Carrying a Concealed Weapon, Receiving Stolen Property, Possession of Drug Paraphernalia, and Possession of Cocaine. Handcuffs were placed on her behind her back and double locked for her safety. I performed a search incident to arrest and located no additional items of evidentiary value.

I transported Deandra to the ______ (Your agency here) and completed the booking process with her. After this, I questioned Deandra in regards to possessing the drugs, pipe, and gun.

Deandra stated she's been addicted to crack cocaine for the past few years and has had to resort to criminal acts to finance her drug habit. She explained her father called police on her when she used his credit card to withdraw money while, which resulted in her felony conviction. Deandra stated she bought the firearm from an unknown person several months ago to protect herself when she buys drugs. She said the baggie with small amount of powder was hers, and has the remnants of crack cocaine inside of it. She also took ownership of the glass pipe.

I transported Deandra to the County Jail and turned over custody of her to jail staff. During their search, a corrections officer inside the jail located 3 rock-like substances wrapped in plastic wrap that had been concealed inside of Deandra's bra. I field tested this and found they also tested positive for crack/cocaine base. The rocks without packaging weighed 0.75 grams.
