ASSUMPTION OF RISK AND RELEASE AGREEMENT (continues on page 3)

This Assumption of Risk and Release Agreement ("Release") is made by me, the undersigned Participant, as of the date set forth below, as follows:

- I have voluntarily applied to Habitat for Humanity of Orange County ("Habitat for Humanity") to participate in construction and other related activities at various locations in Orange County. Some of these related activities include, but are not limited to, construction of new homes, and rehabilitating existing homes. All of the activities referred to in this paragraph are referred to collectively as "Habitat Activities."
- As consideration for being permitted by Habitat for Humanity to participate in Habitat Activities and use their tools and facilities, I agree that I and/or my assignees, heirs, distributees, guardians or legal representatives will NOT sue, make any claim against, or take any other action against Habitat for Humanity, Boys Hope of California ("Owner"), any person affiliated with the Owner, Fullerton Service League of Boys, City of Fullerton, any other sponsor, funder, or corporate involved with the project, named or unnamed, and the suppliers of any of the tools or equipment (collectively, "Released Entities") I may use in Habitat Activities, for ANY injury or damage to me, my property or to any other person or property, resulting from or arising out of my participation in any Habitat Activities, even if caused by or resulting from the negligence or other acts or omissions of Habitat for Humanity or the Released Entities.
- I release Habitat for Humanity and the Released Entities from all actions, claims, or demands that I or my assignees, heirs, distributees, guardians and legal representatives now have or may hereafter have for injury or damage resulting from my participation in any Habitat Activities.
- I understand that Habitat for Humanity and the released entities do not carry or maintain health or disability insurance coverage for any volunteer. I release and forever discharge Habitat for Humanity and the Released Entities from any action, claim or demand whatsoever which arises or may hereafter arise on account of any first aid or medical treatment rendered to me. I understand that EACH VOLUNTEER IS EXPECTED TO HAVE ADEQUATE HEALTH INSURANCE COVERAGE IN EFFECT AT ALL TIMES WHILE PARTICIPATING IN HABITAT ACTIVITIES.
- This Release is intended to be as broad and inclusive as permitted by the laws of the State of California. I understand that I may later discover claims, facts, actions, losses or damages and it is my intention to fully and completely waive and release Habitat for Humanity and the Released Entities from all such unknown matters and claims. This Release shall be governed by and interpreted in accordance with the laws of the State of California. If any clause in this Release is made invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.

I ACCEPT ANY AND ALL RISKS OF ILLNESS, INJURY OR DEATH, AND VERIFY THIS STATEMENT BY PLACING

INFORMATION SPECIFIC TO THIS PROJECT-PLEASE READ!

This project is located at 1310 Kensington Dr., Fullerton, CA 92831 ("Project"). It is a private facility owned by Boys Hope of California ("BHOC"). Habitat for Humanity will be working on the exterior, including, but not limited to, landscaping and yard cleaning, exterior repair and painting ("Project").

"Habitat Activities" are activities which include, but are not limited to, the general construction of new homes, general rehabilitation of existing homes, and the activities described in the paragraph above. The activities described on this page are referred to collectively as "Habitat Activities".

Habitat for Humanity wants volunteers to be aware there are unknown conditions of this or any repair project; it is *your* choice to participate. Should you choose to participate, you are required to sign this release, which is an agreement stating you *cannot* sue Habitat for Humanity, any person affiliated with BHOC and/or the "Released Entities" (listed on page 2, paragraph 2 of this release), for any damages *whatsoever* for any harm of any kind that you might suffer through your participation in this project, in performing Habitat Activities, which are defined above.

In a project of this nature, there are likely many unknown factors and some of them could be hazardous. During the process of exterior and interior repair, there may be hazardous substances released when members are exposed, the existing structure may be rotted, damaged and thus unsafe, and/or the work site may contain other hazards that are not obvious.

You may be working on a property constructed prior to 1978. It is possible that LEAD paint or building materials containing ASBESTOS were used in the home at some point. Both lead and asbestos are known to cause adverse effects on human health. While we don't anticipate volunteers to be in contact with either material, we do want to inform you of the possibility of its existence on project sites.

Volunteers understand that he/she may be exposed to MOLD or other hazardous substance when removing existing building material, as well as interior and exterior structures. Exposure to mold or other hazardous substances for extended periods of time can cause illness or other bodily injury. Volunteers assume the risk to protect themselves by wearing appropriate protective equipment.

It is not possible to know of any of these hazards before the project begins, or even as it is in progress, as hazards may be discovered during the interior and exterior repair. It is not possible for either Habitat for Humanity or the Released Entities to be aware of all the conditions that might exist, even when the structure is exposed.

Habitat for Humanity will conduct this project in a professional manner, and will thus take appropriate steps to do what it can to make the project as safe as possible, but neither Habitat nor the Released Entities can protect you from every possible harm.

Volunteers, by signing this release, do hereby release and forever release and discharge Habitat for Humanity of Orange County and the Released Entities from any claim whatsoever, filed by a volunteer, which arises or may hereafter arise account of any and all injuries, including exposure to mold or other hazardous substances.
